You may ask for the government rate when making your reservation. Present your summons at check-in as proof.

If you elect lodging in excess of the reimbursement rate, you will be responsible for the overage. Jurors should use conventional lodging options (e.g. hotels, motels) for official travel. Non-conventional lodging, properties, or lodging providers (e.g. Airbnb, VRBO, Homeaway) are not eligible for reimbursements.
