Harry Goodheart is a former trial lawyer who has dedicated his professional energy since 1988 to providing mediation in cases throughout the Southeastern United States. He has mediated over 2,600 State, Federal, and pre-litigation cases involving: tort, commercial, construction, community, securities, land use, environmental, probate, professional malpractice, employment, transportation, banking, hospital and healthcare, appellate, agricultural, class actions, law enforcement and inter-governmental disputes. He specializes in assisting Parties and their Counsel resolve complex, multi-party, and difficult-to-resolve civil disputes, utilizing proven techniques and skills in keeping with high ethical standards.

Harry Goodheart is the current President of the American College of Civil Trial Mediators, www.acctm.org, a national association of mediators and dispute resolution professionals who are distinguished by their experience, skill, ethical standards and professional commitment to enhancing the practice of civil trial mediation. He is the 1998 Award of Merit recipient from the Florida Academy of Professional Mediators, in recognition of outstanding contributions to the mediation profession. He has served as President of Mediation Resources, Inc. for over fourteen years. With 30 years' experience as a Florida lawyer ("AV" rating, Martindale-Hubbell), Harry served two terms as a member of the Board of Governors of the Florida Bar (1979-1983); is a Life Fellow of the Florida Bar Foundation; and is included in *Law and Leading Attorneys: Florida Consumer Guidebook: America's Most Respected Counsel as Judged by their Peers*.

Harry is admitted to The Florida Bar (1973-), the U. S. District Court, Middle District of Florida (1975-), and the U.S. Court of Appeals, 11th Circuit (1981-). He is an Associate Member of the South Carolina Bar. He served as a member of the Florida Supreme Court Rules Committee for Mediation and Arbitration from 1994 to 2001, and was instrumental in developing and revising Florida's ethical standards for certified mediators. An Air Force Vietnam veteran, he is a graduate of Culver (with Honors, 1962); Washington and Lee University (BA, 1966); and the University of Missouri, Kansas City, School of Law (JD, 1973). Harry clerked for Ben Spalding, Office of General Counsel, Mobil Oil Corporation, during law school, and then practiced trial law in Bradenton, FL from 1973 until becoming a full-time mediator in 1990. Harry's specialized mediation training includes the Harvard Negotiation Program with Roger Fisher and Bill Urey, Litigation Risk Analysis with Marc Victor, and Advanced Hostage Negotiation with FBI negotiator and trainer Fred Lanceley.

Harry was instrumental in developing the Florida Twelfth Judicial Circuit's Model Mediation Program, and served as a consultant for a number of other Circuits and for the Florida Department of Insurance (Hurricane Andrew) and Department of Labor (Workers' Compensation), assisting in the implementation of dispute resolution systems. Harry has provided basic and advanced mediator and negotiation training, seminars and workshops throughout Florida, in the Carolinas, and other states since 1989. He and Cotton C. Harness III, of Charleston, SC, have provided the Certified Circuit Civil Mediator Training Program sponsored by the South Carolina Council, Bar and University of South Carolina School of Law since 1995. In the last two years, he has provided Mediator Certification training for the Mecklenburg County Bar in Charlotte, NC.
