FEDERAL SENTENCING GUIDELINES SEMINAR

Training Notice

The United States District Court for the District of South Carolina will provide a Federal Sentencing Guidelines Seminar which will be hosted by the United States Probation Office on January 14, 2026 (full day), and January 15, 2026 (half day), in four locations throughout the District of South Carolina: Greenville, Columbia, Florence, and Charleston. Check-in each day will begin at 8:30 a.m. until 8:55 a.m., and the seminar will begin promptly at 9:00 a.m. The United States Sentencing Commission will provide training advisors who will speak on the following topics:

January 14, 2026: Commission Update, Chapter Three Adjustments, Advanced Topics (application of cross references, proper use of pseudo counts, etc.), and Multi Defendant Cases (additional hour of Ethics provided by the Federal Public Defender's Office)

January 15, 2026: Chapter Five and Chapter Seven, Commission Update, and Statement of Reasons Update

This seminar has been approved for 7.5 CLE credits and 1 additional credit for Ethics, for a total of 8.5 hours. There is no registration fee for this seminar; however, space is limited so please register as soon as possible. To register, complete and submit the attached form by December 31, 2025. Please send the form by using <u>one</u> of the two options listed on the form.

Please remember to bring your Guidelines Manual or download the Guidelines Manual from the United States Sentencing Commission's website to your electronic device before arriving at the seminar.
